- 2. Ten items on the R6-1 upfit were not completed as specified in the bid contract. Chip moved to withhold the final payment for the upfit until all issues have been resolved. Tom seconded, motion unanimously carried.

- 2. Now that the upfit on R6-1 is mostly complete the commissioners agreed that the insurance coverage on the truck should be increased to reflect the total replacement cost of the apparatus. It is currently insured for just the cost of the cab and chassis. Patt will contact Enduris to increase the coverage.
