# Monthly Commissioner Meeting Minutes July 16, 2018

## Changes/Additions to Agenda:

1. Chief Swagerty was not in attendance so the Chief's Reports, Mechanic's Report, Financial Report Item #3, & Old Business Item #2 were postponed.

### Financial Report:

- Two insurance recovery checks totaling \$12,860.72 have arrived from Enduris. One in the amount of \$12,670.72 was for the agreed upon cost of repairs less depreciation and deductible and the other in the amount of \$190.00 was for the increase in the electric bill and initial volunteer clean-up/ drying after the leak was discovered. Patt will deposit them into the district's fund on Thursday.
- 2. (5) Warrants totaling \$846.73 were requested on the Claims Payment Request dated 7/16/18 as follows:
  - \$200.00 for monthly secretarial services
  - \$125.53 for monthly utility service
  - \$16.26 for gas can for R61
  - \$75.00 for dispatch services
  - \$429.94 for plumbing repair and urinal removal

Chip moved to approve the request, Scott seconded, all three commissioners signed the Claims Payment Request.

#### **Old Business:**

- 1. The Application for Eligibility in the State of Washington Surplus Property Program remains a work in progress.
- 2. Status report on new district T-shirts for new recruits was postponed.
- 3. Evergreen Adjustment Services has calculated the replacement cost value of the water damage at the station to be \$19,429.29. They have recommended that Enduris send the district \$12,670.92 to begin repairs and retain the "depreciation" of \$5,758.37 to be paid to the district once all repairs have been made. In accordance with the policy, the district will pay a deductible of \$1,000.00. As of today, the leak has been stopped, the urinal has been removed and all the plumbing in both bathrooms has been inspected and deemed sound.

#### New Business:

1. Upon removing the molding from the floor on the south wall of the meeting room, it was discovered that some of the studs under the windows were rotted. Chip motioned that enough drywall be removed to expose all areas of previous water damage. All agreed, motion carried. He further moved that any rotten framing found be replaced or repaired, all present agreed, motion carried.
