Changes/Additions to Agenda:

1. Chief Swagerty was not in attendance so the Chief's reports, the mechanic's reports ,and old business item #5 were postponed until Chief Swagerty is able to deliver them.

Minutes of the previous month's minutes were read, approved, and signed by commissioners Keen and Rosmond.

Financial Report:.

- 1. (7) Warrants totaling \$783.12 were requested on the Claims Payment Request dated 4/15/19 as follows:
 - \$200.00 for monthly secretarial services

Old Business:

- 1. The Application for Eligibility in the State of Washington Surplus Property Program remains a work in progress.
- 2. The new flooring has been laid. Tom has ordered all new molding for the room and new hand rails for the bathrooms. He will install the molding after the new windows on the south west wall have been installed. Since the SW wall damage was not part of the the insurance claim, all work related to the claim has been complete. Patt will contact the insurance adjuster for final payment.
- 3. We are continuing to take bids for the south west wall repair project.
- 4. The exterior lights have all been installed. The light above the bay doors is so bright it may impede drivers on 110, especially when turning onto Mora Rd. Chip moved to have a hood installed over the light to better direct the lighting and shade areas that do not require illumination. Patt will find out if the manufacturer of the fixture makes such a hood and if not, will meet with a local metal smith to have one custom made. Also two of the lights were supposed to be motion activated. Patt will check with Chief Swagerty, who worked with the electricians on this project, to have that rectified.
- 5. Reports on the status of an emergency generator were postponed until Chief Swagerty is available to deliver them.

New Business:

1. The commissioners reviewed and discussed the insurance policy renewal from Enduris for 2020. Since the premium provides for a replacement cost which is close to 80% of the projected actual cost of replacement, which is estimated at \$450,000.00, the commissioners unanimously voted to accept the renewal as stated. Chip will contact Enduris and complete the renewal process.
